Present: Chairman Tom Horrigan, Secretary/clerk David Steinman, Norma Bennun, Chris Bolick, Helen Wong, regular members; Matt Snyder and Mark Winik, alternate.

Meeting called to order at 7:31 p.m.

1. <u>Minutes</u>: Motion was made to accept previous meeting minutes as written (#2 on Agenda).

2. Old Business

<u>Application #2013-1 Public Hearing</u>: Owner/Applicant Gerald Mastroangelo #269 Shore Drive Short Beach CT – requests, per Section 7.1 Schedule A Line 4 Maximum Height of Buildings a variance from 30feet to 40 feet. Representing Mr. Mastrangelo was Bob Small. Mr. Mastraoangelo was present at meeting. Plans call for a raising and redesign of structure in established FEMA VE Zone. Height was the only variance requested for project on application.

Chairman raised concern that the applicant's plan package was not originally presented to CASB Zoning Board per denial. Chairman pointed out that there may be pre-existing nonconformities on building site that weren't originally addressed by applicant or CASB zoning board. Several items on the plan package, including changes to the existing roofline, the addition of porch and other new construction – new items that weren't presented to the CASB Zoning Board - are important variances to address. **Action** - since these project points weren't presented to CASB board for consideration, the application package needs to be returned to CASB for review. **Application withdrawn**.

3. New Business:

<u>Application Accept #2013-2:</u> Owner/Applicant Barry Michael Vener and Maureen Moore Vener #40 Farm River Road Short Beach, CT, represented at meeting by Atty. Al Ippolito, requests per Section 8.5.5 to build a retaining wall within a sideline setback. Original application cited CASB ZB denial based on 8.5.4 – pertaining to rock slopes when proposal was actually deemed a retaining wall – sec 8.5.5.

The Veners are applying to build a 30' long retaining wall along a property for safety and to comply with having to build a required fence since retaining wall would be higher than 4 feet. Lengthy discussion was held regarding the adjoining property owner's knowledge and consent for submitted plans, the resolution of two different survey plots between the adjoined property owners, and overall plans and application review. **Action** – Application accepted contingent on a stipulation that the CASB ZB clarify that the original denial was based on Reg. 8.5.5 and not 8.5.4 prior to a hearing AND that a letter from the adjoining property owner or their attorney, their presence and statement at a hearing, or representation by owner at hearing, be presented to board acknowledging consent for plans be presented at hearing.
