The regular meeting of the Executive Board of the Civic Association of Short Beach was held on Monday, April 8, 2024, at 7:00 pm at the Short Beach Union Church.

Doug Hanlon Called the meeting to order at 7:05pm.

- Final review of the minutes of February meeting.
 - Peg Carpenter made a motion to approve minutes as written. Chris Collins seconded. All in favor.
- Report of the Treasurer

- Zoning Applications or actions taken by ZEO
 - Application, Linda Sansone, 91-93 Highland Avenue
 - Demolish and rebuild
 - o Mike Santone Linda's husband made presentation to board.
 - o Rebuild house to meet current set backs per regs
 - o Two family to one family
 - Regulation 4.7.1 supports building a fully conforming structure on a non-conforming lot.
 - o Height with flat roof is 20-21 feet which is within regulations
 - o Lot coverage is within regulations.
 - Francesca Bickel moves to approve the application of Lina Sansone to demolish and rebuild house number 91 Highland Avenue in accordance with regulation 4.7.1. The current use of the structure as a two-family house will be abandoned and a single-family structure will be built. A Certificate of Zoning Compliance will not be issued unless an as-built survey is provided showing the position of the new structure on the lot and how it conforms to the zoning regulations.

Brian Funaro seconded. All in favor.

• Unfinished Business:

- o Report on meeting—Sanitation Committee meeting, kickoff and basic planning
 - We've done all we can do until we hear about the grant should be hearing soon about the grant
 - Doug met with RTM representatives and they agreed to write 10,000 dollars into the budget so we will either have more money or we'll at least have that if we don't get the grant
 - An application to the community foundation has also been submitted should hear on that one in May
 - Doug and Chris will set up another meeting with the RTM representatives.
- o Wall of "thank you" on the website: suggestions for February/March
 - Carleen Davis for her service on the ZBA of 7 years
 - Brian Funaro and Luke Carpenter for taking over the water testing that Greg Carpenter used to do for Friends of the Farm River and Save the Sound for Unified Water Study.
- o Andi Hallier, ZBA
 - Report on hiring of Stenographer
 - State statute requires that you record or transcribe a public hearing
 - ZBA met 9 times last year and 8 of them were public hearings on appeals
 - Two cases pending in court in New Haven
 - Andi Hallier has reached out to the town for a stenographer 400 dollars a session if over two hours or 95 dollars an hour for a meeting less than two hours
 - If the ZBA had had a stenographer last year for the 8 public meetings 1300 to 1800 dollars per year.
 - CASB estimates 2 hours per year
 - Chris Collins made a motion to budget 2,300 dollars for stenographers for the ZBA and CASB in case of public hearings.
 - Dave Engler seconded. All in favor.
 - New---Discussion of revisions to zoning forms
 - o form 30 and 30A have been revised by ZBA –
 - o Inconsistencies between ZBA and CASB forms
 - Consider making the form fillable
 - Suggests forming a joint committee to streamline forms between ZBA and CASB
 - ZEO, David Perkins and Dave Steinman from ZBA will work together on this

- Carleen Davis has resigned from the ZBA. Stu Sokol has volunteered to be on the ZBA.
 - o Brian Funaro made a motion to nominate Stu Sokol to the ZBA to replace Carleen Davis until the end of her term in June 2026.
 - Francesca Bickel seconded. All in favor.
