- 2. Report of the Treasurer as reported by Peggy Carpenter as of11/30/22 in savings \$51,642.11, and \$63,318.75 in checking.

 - a. Deliberations on Application on Rosenberg Property, 14 Rockland Park. Chris Collins made a motion to deny this application based the following

The structure is not an unroofed terrace and does not meet the exceptions of 7.4.3; The structure is a patio and violates the setback provisions of 7.4 schedule A line 5f sideline setbacks and line 5b read line setbacks.

Portions of the retaining wall built at 14 Rockland Park are not 10 feet away from the retaining wall at 18 Rockland Park in violation of 8.5.5(4).

The joint application process of 8.5.9 is not relevant nor application since what is proposed is not earth moving but is the construction and not all the owners of abutting properties have signed the application.
